<u>Enotas</u> local fraternity at the University of South Florida has achieved distinction in a broad area of accomplishment: service, campus leadership, scholarship and intramurals.

INTRODUCTION

The men of Enotas Fraternity have assembled and are presenting the information contained in the following pages of this booklet for the purpose of acquainting the reader with the role of Enotas Fraternity in the University Community.

Since its formation in 1960 Enotas Fraternity has had as its underlying goal, fulfillment of the six basic fraternity criteria as developed by the National Interfraternity Council. They are:

- 1. That the objectives and activities of the fraternity should be in entire accord with the aims and purposes of the institution.
- II. That the primary loyalty and responsibility of a student in his relations with his institution are to the institution, and that the association of any group of students as a fraternity involves the definite responsibility of the group for the conduct of the individual.
- 111. That the fraternity should promote conduct consistent with good morals and good taste.
 - IV. That the fraternity should create an atmosphere which will stimulate substantial intellectual progress and superior intellectual achievement.
 - V. That the fraternity should maintain sanitary, safe, and wholesome physical conditions in its living areas.
- VI. That the fraternity should inculcate principles of sound business practice both in chapter finances and in the business relations of its members.

The Brotherhood of Enotas Fraternity has, in fact, met and exceeded the challenge of the above criteria.

This booklet was prepared in an objective manner as a guide to Enotas Fraternity leaving the reader to make his own evaluation.

Enotas Fraternity was organized in the fall of 1960. At first, athletic participation was the primary goal of the eleven charter members. As the year passed, the new brothers met a tremendous challenge. This task was that of laying the foundations of a fraternal organization. With hard work and determination Enotas Fraternity began to emerge. Early in 1961, Enotas was granted its charter by the University. The charter members and officers are:

The scholastic year 1961-62 was one of many firsts for the newly chartered fraternity and for the University. With the initiation of the charter pledge class, the fraternity gained in enthusiasm and energy. In the spring of 1962, Enotas pledged its second and largest pledge class; thirty-two sophomores. During this same period, Enotas brothers entered into the political activity of the campus when Frank Meiners and David Aycock were elected Vice President and Treasurer respectively of the Student Association. Also initiated during this period were two service projects: Keep U.S.F. Campus Clean, and the sponsoring of an orphan in Lakeland. The brothers again experienced success in athletics, winning the first intramurals championship.

The scholastic year of 1962-63 was a year of continued success for the members of Enotas Fraternity. The social calendar of the fraternity improved with major functions at the Phi Delta Kappa house, the International Inn, and an authentic Hawaiian Luau. The fraternity continued to support the orphan in Lakeland and also added a Coke sale at the Gasparilla Parade to its list of service projects. Frank Meiners, Charter pledge, continued his success in University politics by being elected President of the Student Association. The olive blazer of Enotas became a part

of campus dress as did the gold and black jersey on the intramural fields. During the year 1962-63, the fraternity was runner-up champion in intramurals.

The scholastic year 1963-64 was one of shifting emphasis for the members of Enotas Fraternity. The membership was growing in maturity and therefore, greater stress was placed on academic endeavors. The test file was started and proved to be of tremendous benefit to the brothers. Not only did the brothers experience success academically, but they continued to demonstrate the desire to win in Greek Week activities and intramural sports. Once again the fraternity sold Cokes at the Gasparilla Parade. That year, twenty per cent of the profits went to the Tampa Chamber of Commerce, twenty per cent to the U.S.F. Scholarship Foundation and the remainder of the profits were placed in a nationalization fund.

All officers must maintain a 2.0 GPR to be eligible for election, and must have been an active brother for at least one trimester. Normally, we elect individuals who have been active brothers for two trimesters, as they have a greater working knowledge of all aspects of the fraternity.

The President, Vice President, and Treasurer are elected in December for a period of one year. The remaining officers are elected each trimester. Because six officers are elected each trimester, more men are able to gain a working knowledge of the administration of a fraternity or almost any organization which they might later encounter. This we feel is valuable training in leadership techniques. We encourage brothers and pledges to attend the Leadership Training programs sponsored by the University Center for application in the fraternity.

Executive Council

Composed of all the officers with the Vice President acting as chairman.

The Executive Council presents to the fraternity for approval dues, assessments, and fines which shall cover the necessary areas of income.

The Executive Council acts as the "governing body" of the fraternity.

The Executive Council meets each trimester as a Finance Committee.

High Court

Composed of Vice President acting as Chief Justice and four other brothers appointed by the President.

The High Court handles all cases of conduct and violations of the constitution and/or by-laws.

Fines or suspension or any other disciplinary action or any combination of the three shall be considered just action for violating moral, social, or legal standards. Appeals are heard by the Executive Council.

Committees

Committees play an especially important role in Enotas leadership training program. Experience gained through committee work prepares each brother for accepting positions of greater responsibility. Committee chairmen are appointed after serving for one or more trimesters on that committee. Near the end of each pledge period, we allow each pledge to choose one or more committees he wishes to serve on, so that he can immediately become aware of the functioning of that committee.

Meetings are held once each week and average two to three hours in length. All meetings are conducted by Sturgis' Standard Code of Parliamentary Procedure. The Parliamentarian is empowered to fine brothers for absense, tardiness, or rowdiness.

CONSTITUTION OF ENOTAS FRATERNITY University of South Florida

PREAMBLE:

Enotes Fraternity is an organization whose objectives are to instill strong character and unity among its members, to encourage scholastic and social prominence, and to help build and maintain the traditions of the University of South Florida.

ARTICLE I: MEMBERSHIP

This fraternity shall be composed of men of good moral character who shall be initiated according to the laws of the fraternity and the governing regulations at the University of South Florida.

ARTICLE II: MEETINGS

Regular meetings shall be held weekly at 7:00 P.M. at a location designated by the University Center. All other meetings shall be called by the President or the Executive Council.

ARTICLE III: FINANCE

The executive council shall be empowered to present to the fraternity for approval, dues, assessments, and fines which shall cover the necessary areas of income.

ARTICLE IV. OFFICERS

Section 1 - Officers:

The officers of this fraternity shall be in descending rank order as follows: 1. President, 2. Vice President, 3. Treasurer, 4. Recording Secretary, 5. Corresponding Secretary, 6. Parliamentarian, 7. Pledgemaster, 8. Chaplin, 9. Interfraternity Council Representative.

Section 2 - Term:

The President, Vice President, and Treasurer shall hold office for a term of one year, beginning with January of the Spring Trimester and ending the same day one year hence. The other officers shall be elected every trimester.

Section 3 - Eligibility for Election:

Every officer must have a 2.0 grade point ratio before election to office. The offices must be filled by members who have been active brothers at least one trimester.

Section 4 - Election:

Nominations for office shall be opened on a meeting date to be determined by the President and shall continue for one week, whereupon nominations shall be closed and the votes shall be cast. A majority of the votes cast shall be necessary for election. Section 5 - Oath of Office:

Upon assuming office each officer shall take an oath to be administered by the President in the following form:

do solemnly swear that I shall faithfully execute the duties of the office of of Enotas Fraternity and that I shall, to the best of my ability, observe, protect and maintain the constitution and by-laws of Enotas Fraternity, so help me God.

Section 6 - Vacancies

In the instance of the President's office being vacated the Vice President shall immediately assume office and a new Vice President shall be elected at the next regularly scheduled meeting. In all other instances of vacancies the President shall appoint an eligible member of the fraternity to such vacancy for the remainder of the unexpired term, subject to the approval of the fraternity.

Section 7 - Recall:

Any officer may be recalled by a two-thirds vote of the fraternity.

Section 8 - Advisors:

There shall be a minimum of one and a maximum of three faculty advisors to serve this fraternity. The advisors shall offer suggestions and shall represent the interests of the fraternity to the faculty and administration.

ARTICLE V: COMMITTEES

Section 1 - Committees:

Any committee may be initiated at the discretion of the President.

Section 2 - Executive Council:

The executive council shall consist of all the officers of the fraternity. They shall be responsible for acting as the governing body of the fraternity. They shall hold separate meetings for the purpose of discussing pertinent business and shall make suggestions and present these at the next scheduled meeting.

ARTICLE VI: AMENDMENTS

This constitution may be amended or repealed by a two-thirds vote of the members present at any regularly scheduled meeting. All said amendments and/or repeals must be presented in writing for consideration before the question is to be decided.

ARTICLE I: MEMBERSHIP

Section I - Alumni

Alumni shall be defined as brothers who have been duly initiated as undergraduates and who have left the university. The brother must be in good standing with the fraternity and the University of South Florida. A brother leaving for one or more trimesters who plans to return eventually will be considered alumni while gone but will be reclassified upon registration for classes. This definition shall exclude those brothers on work-study.

Section 2 - Undergraduates:

ACTIVE: Any brother in good standing with the university and with the fraternity

Any brother in good standing with the fraternity who SOCIAL: is on academic warning. The social member is required to attend regular meetings, rush meetings, and the Gasparilla Coke Sale, and no others, unless he so chooses. The social member must pay the regular dues and assessments and must bear in mind that as a social member he is a detriment to the best interests of the fraternity and he should utilize his privileged position to attack his poor grades with zest. (See Article 11, Section 3)

SPECIAL: Any brother who feels he does not fit into one of the above classifications shall present his case in writing to the High Court no later than the second regular meeting of any trimester. Warning: Any brother attending this university who does not see to it that he fits into one of the above classifications no later than one month from the first regular meeting will automatically be expelled from this fraternity.

Section 3 - Faculty Membership:

Members of the University of South Florida faculty may be elected to membership by this fraternity and when duly initiated shall be classified as alumni members and shall be treated accordingly.

Section 4 - Pledgeship Bids:

When extending bids to pledgeship the following procedure shall be utilized:

A. The prospective's name shall be mentioned and blackball votes shall be asked for.

B. If the prospective receives one or less votes he shall receive a bid.

C. If he receives more than five votes he shall not receive a bid. If he receives from two to five votes then three people shall D. be asked to speak against him and three people shall be asked to speak for him in the order of against, for-against, for-againstfor.

E. A revote shall then be cast upon which two or more balckballs cancels the bid and one or less blackballs allows the bid to be sent.

Section 5 - Election to Brotherhood:

When electing a pledge to brotherhood the following procedure shall be utilized:

A. The pledges name shall be mentioned and blackball votes shall be asked for.

B. The pledge shall be elected if he receives one or no votes. C. If the pledge receives two or more votes three people will be asked to speak against him and three people will be asked to speak for him in that order. Then the pledgemaster and his big brother will speak for or against him according to their sentiments.

D. A revote shall then be cast upon which two or more votes cancels the pledges right to brotherhood and one or no votes elects him to brotherhood.

Section 6 - Depledging:

A majority vote at any regular meeting is necessary to request an affiliate to depledge. An affiliate may voluntarily depledge by presenting notice in writing to the fraternity.

Section 7 - Expulsion of Brothers:

Any brother may be expelled from the fraternity for any reason deemed sufficient by the brotherhood. Action against a brother must be presented in writing at a regularly scheduled meeting. The brother must be asked to defend himself before the vote can be cast. The membership of the brother may be canceled by a threefourths vote of all the brothers present at any meeting at which a quorum is present. A brother is also subject to automatic expulsion as stated elsewhere in these by-laws.

Section 8 - Membership:

Membership in this fraternity shall be for life except as provided in these by-laws. Membership may be terminated only by death, expulsion, or a formal resignation. Every member shall be obligated to obey the constitution and the by-laws as they are now and may hereinafter be amended.

ARTICLE II: MEETINGS

Section I - The president and/or the executive council shall have the power to schedule regular fraternity meetings and any necessary special meetings.

Section 2 - A meeting may be called at any time by a majority vote of the members.

Section 3 - Regular Meetings: A. The only excuses allowed as legal for missing a meeting shall be as follows:

- (1) When a brother has a class on the meeting night.
- (2) When a brother has to work on a meeting night.
- (3) When a serious emergency or a serious illness affects a brother.
- (4) When a brother is on academic warning.

 (5) Hardship cases shall be referred to the High Court.
 B. All legal excuses must be submitted in writing to a member of the executive council before the call to order of the meeting missed. If no excuse is offered the absence shall be termed illegal. C. All excuses other than the aforementioned shall be designated illegal. A two dollar fine shall be levied for every illegally missed meeting. A fine of five dollars shall be levied for illegally missing two consecutive meetings.

D. When a brother misses a total of three meetings in any one trimester he shall be required to appear before the High Court for remedial action.

Section 4 - Called Meetings:

Any reasonable excuse shall be acceptable for missing any called meeting if given to a member of the executive council before or during the next regular meeting. If no written excuse is offered there shall be a three dollar fine.

Section 5 - Tardiness:

Any brother entering a meeting for the first time after the call to order shall be required to pay a one dollar fine. Excuses shall be determined valid or invalid by the High Court. Fines are due the week after the incident.

ARTICLE III: FINANCE

Section I - Dues shall be assessed at the rate of twenty-five dollars per trimester. Alumni dues shall be five dollars per trimester with further contributions accepted if willed. No special assessments will be made to include alumni.

Section 2 - All brothers dues shall be paid by the third regular meeting of each trimester. Special cases may appeal to the High Court within a week after the date due. All delinquents shall be referred to the High Court for immediate action.

Section 3 - Deliquent Bills:

The following regulation shall govern the payment of all monies to the fraternity unless otherwise stipulated in this constitution or by-laws.

A. All bills are payable in advance and are due and payable within seven days after notification.

B. If the bill is not paid on the seventh day after due date a ten per cent fine shall be added to the amount owed.

C. If the bill still remains unpaid on the fourteenth day after due date an additional twenty per cent fine shall be added to the amount owed.

D. If the bill still remains unpaid in full by the twenty-first day after due date all privileges of the brother shall be suspended.

E. If the bill is not in full within fifteen days after suspension the brother is automatically expelled from this fraternity. F. The university shall be advised of the action taken in (E) and the Treasurer shall request college officials to withold the grades and degree of the student until such time as his account is settled in full.

ARTICLE IV: OFFICERS DUTIES

Section I - President:

The President shall be the official head and chief executive of the fraternity. It shall be the duty of the President to preside at all regular and special meetings of the fraternity. He shall be an ex-officio member of all committees. He shall rule on all questions of law and order. He shall preside at the initiation of all new members and installation of new members and installation of new officers. He shall personally or by his duly appointed representative countersign all checks and approve all disbursements. He shall appoint all committees and appoint committee in conjunction with the Vice President. He shall enforce the constitution, by-laws, traditions and ritual, and university rules and regulations.

Section 2 - Vice President:

The Vice President shall perform all the duties of the President in his absence or inability to act. He shall be the chairman of the executive council. He is a member of and is responsible for the coordination and correct functioning of all committees. He shall be the Chief Justice of the High Court. He shall serve at all times as the executive assistant to the President.

Section 3 - Treasurer:

It shall be the duty of the Treasurer to keep a full and accurate account of all the financial matters relative to the organization, maintenance and activities of the brotherhood. He shall collect all dues, assessments, fines, etc., owing and payable by the members of the chapter; active or alumni. He shall issue checks in payment of all bills arising from the routine of the business and the maintenance of the brotherhood, with the countersignature of the President or his duly appointed representative. He shall handle orders, payments, and deliveries concerning pins, stationery, or other fraternity paraphernalia. He shall preside at meetings, etc. in the absence of the President or Vice President, or their inability to act. He shall prepare in conjunction with the social chairman a budget acceptable by the fraternity at the third regular meeting of every trimester.

Section 4 - Corresponding Secretary:

It shall be the duty of the Corresponding Secretary to give notice of all special meetings to the members of the fraternity. He shall receive all communications and submit the same for the action of the fraternity. He shall keep a roll and profile of the membership of the entire fraternity active and alumni in a card file system. He shall actively maintain all fraternity correspondence, including thank-you, condolence, and get-well literature. He shall compile an address book each trimester of the currently enrolled brothers and pledges and distribute one to each brother by the fourth regular meeting.

Section 5 - Recording Secretary:

It shall be the duty of the Recording Secretary to keep accurante minutes of the proceedings of the fraternity. He shall perform such other duties which may be delegated to him by the brotherhood or its officers. He shall keep and maintian the constitution and by-laws of the fraternity. He shall be custodian of the ritual and archives of the chapter.

section 6 - Parliamentarian

The Parliamentarian shall keep order during all sessions of the fraternity by Sturgis' Standard Code of Parliamentary Procedure. He shall attend door during all meetings. He shall distribute and collect ballots. He shall submit weekly news to the university newspaper. The public-relations of the fraternity shall be his responsibility.

Section 7 - Pledgemaster:

The Pledgemaster shall carry out his duties as outlined in the pledge manual.

Section 8 - Chaplin:

The Chaplin shall render a prayer at the opening of each fraternity meeting. He shall render a prayer at banquets and other such functions. He shall be responsible for the spiritual welfare of the fraternity, and shall be responsible for all religious matters.

Section 9 - Interfraternity Council Representative:

He shall conscientiously attend all IFC meetings and render a written report of all activities.

ARTICLE V: PROCEDURES

Section I - The High Court

The High Court shall consist of the Vice President acting as Chief Justice and four judges to be selected by the Vice President in conjunction with the President, and with the approval of the fraternity. All judges will serve until resignation or removal by the President.

The High Court shall meet every week at a time agreed on by the judges provided it is before the brothers' meeting. The High Court shall handle all cases of conduct and violations of the constitution and/or the by-laws, and fines levied in accordance with fraternity regulations. In addition it shall handle the classification of the brothers at the beginning of each trimester. All cases not included in the above shall be brought before the executive council for action. All decisions of the High Court shall be final unless appealed by the defendant. All appeals shall be to the executive council and a total of one per violation is allowed. The executive council will decide whether or not to hear the case according to its established rules.

The exception to the above rules shall concern matters of expulsion in which case the procedure in Article 1, Section 7 or the by-laws shall be utilized. The High Court shall act on cases brought to its attention and on cases lit becomes aware of independently. Albrother wishing to bring action must file a written complaint with the court. The defendant must appear when requested or send his duly appointed representative. The accuser need not appear unless he so desires. Absence of the defendant shall indicate lack of interest and shall not halt the hearing of the case. Anyone may attend a session of the court but only the defendant, the accusers, and any witnesses will be allowed to speak.

Fines or suspension or any other punishment or any combination of the three shall be considered just action for the court for violating moral, social, or legal standards. Suspension shall be defined as: the revocation of the right to attend or participate at any and all fraternity functions. Anyone suspended must apply to the High Court for reinstatement of his privileges. Cases must be brought before the High Court within one week form date of incidence and must be appealed by the next regular High Court meeting following action taken by the High Court or for fines.

Section 2 - Committees

Committee reports shall immediately precede old business in the order of meetings. The committee chairman is responsible for complete fulfillment of the committee's assigned function. The committee's ideas and suggestions must be offered in written form in a concise and complete manner. Discussion will be allowed and motions from the floor will be in order after the report has been completely read. Alterations, additions, and deletions will take place during the discussion. Each report, after all discussion, must be reread with corrections inserted and must then be accepted or rejected. Accepted reports will constitute fraternity agreement and the prescribed (if any) action will be taken.

Section 3 - Pledge Treatment:

A. No hazing will be tolerated.

B. Request nothing that is publicly embarrassing.

C. At no time require a pledge to do anything if he is studying. D. Do not go to extremes; treat pledges with the idea of helping them to better themselves.

E. Study hours are from seven to eleven p.m., Sunday through Thursday.

F. The fraternity does not condone any form of hazing. G. A pledge may not be initiated into the fraternity unless he has met all his financial obligations to the fraternity.

ARTICLE VI: AMENDMENTS

Any by-law may be amended, added, repealed, or rejected by a threefourths majority vote of the members present at any regular meeting. Organization of Enotas Fraternity

FINANCIAL STRUCTURE

The financial standing of Enotas Fraternity is based upon soundly advised management and long established constitutionally defined procedures of collection. This foundation has produced a financially sound fraternity. We have a consistent record of good credit while dealing extensively throughout the Tampa business community. Operating on budgets ranging from \$2,000 to \$2,500 each trimester, our program is the largest and most comprehensive of any fraternity on campus. This record reflects our belief that a fraternity cannot be strong and worthy of its name unless it has a sound financial base to stand on.

To insure the continued soundness of this base, before each trimester begins the Executive Council meets with our advisor as a budget committee to allocate expenses for the coming trimester. Two main considerations are an integral part of this budgetary planning. The committee attempts to insure that projected expenses will match expected revenues. We do not believe that it is the fraternity's business to make a profit from its members nor do we believe in spending more money than is available. We have consistently maintained beginning and ending working capital balances of 20% of our total budget for the trimester. These funds are used as a reserve for the beginning of the next trimester's expenses.

Our sources of funds generate from three major areas. The heaviest concentration is dependant upon our dues which are set at twentyfive dollars per trimester. In addition to these dues, we obtain funds from our projects. The projects committee, each trimester, is responsible for planning at least one fund raising project. In the past, the major portion of this money has been reserved for expected nationalization expenses. Currently over eleven hundred dollars has been placed in savings for this purpose. The pledges, with the guidance of the projects committee, hold a fund raising project in addition to the brotherhood's. These funds are appropriated to cover pledge class expenses, and are administered by the pledge class treasurer under the guidance of the chapter treasurer. Our final source of funds is generated from fines and assessments. Although our fine system is not designed for the purpose of producing revenue, in its operation some revenue is produced. This money, in general, is always appropriated to the current trimesters expenses, therefore, benefiting the group as a whole during the period in which the infractions occurred. In addition to the fines, there is a small amount of revenue generated from assess-It states in our by-laws that assessments other than ments. those which might be termed purchases are not allowed. In following this principle, we operate on a no assessment basis. The only funds received from assessments come from the sale of party They are generally sold at half cost to the brothers. favors.

In order for the funds compiled from these three sources to be effectively used, our procedure of collection is of primary consideration. This leads to the second basis of our financial soundness. Our by-laws define a strong and effective method of collection.* From the date debts are payable to the fraternity, a member has three weeks for payment. Each week he is delinquent he must pay a 10% interest charge on a graduated scale. Therefore, in the third week he will pay interest at the rate of 30%. After three weeks the brother who is delinquent is brought before the High Court for suspension and can be expelled if the debt is not cleared. We are of the opinion that in order to operate with fairness to all and any degree of soundness, that a financial policy of this nature is necessary. If a brother has extenuating circumstances that prevent his fulfillment of his financial obligations. he can take his case before the High Court. The court will decide upon his circumstances and afford whatever adjustment they think is warrented. Responsibility in meeting financial obligations is stressed not only on a chapter level but also on an individual basis.

We are proud of our strong financial foundation, and we hope that this has given an insight into the process by which it has been achieved. Our current standing is outlined in the financial statements which follow this report.

RUSH PROGRAM

The Interfraternity Council of the University of South Florida sponsors two rush programs each year. The first of these is in the fall, approximately four weeks after the trimester has begun. This rush is primarily for junior college transfers and outstanding Sophomores and Juniors. First trimester Freshmen are deferred until they have completed 12 hours. During this program, we emphasize primarily scholarship, since these men are interested in the mature facets of fraternity life.

The Spring Rush is composed mainly of Freshmen who have completed 12 hours satisfactorily with a 2.0 GPR during their first trimester. This rush is generally much larger than the fall rush, because most freshmen are eligible to rush. During this period, we stress leadership and social activities, since we are attempting to reach a younger group.

During both rushes, there are many ideas and accomplishments we emphasize. We point out that fraternity life is not too demanding to maintain above average grades and that Enotas requires from its brothers and pledges academic performance on a level that is necessary for graduation. We also stress the fact that Greeks, and particularly Enotas brothers, are the campus leaders, and that a good deal of leadership training and experience can be attained through work in the fraternity. Next, we point out the opportunities for participation in intramural sports which are available in fraternities and particularly in Enotas fraternity. One of the most important facets which we stress in our fraternity is the closeness and spirit of our brotherhood. This we achieve through our actions and relations with each other, and we find it unnecessary to have to make flowery proclamations to the rushee. Above all, Enotas stresses individual expression in opinions, beliefs, and activities. We believe in assisting the individual to develop along the lines which fit his particular talents.

In addition to these I.F.C. sponsored programs which last approximately one week, we also conduct a year-round rush. Our year-round rushing program has several aspects. One of these is rush parties in the summer and early fall. The intention of these parties is not only to become more acquainted with the prospective rushees, but to provide a means by which rushees can become familiar with our fraternity and fraternity life. Later in the fall and in the spring, we continue our rush parties with the emphasis on freshmen and sophomores.

A second aspect of our year-round rushing involves each brother and pledge visiting his local high school and/or junior college and obtaining a list of men transferring or planning to attend the University. These lists are accumulated in our permanent rushee file. Members of the rush committee correspond with these men describing the University, the fraternity system, and particlarly Enotas. Still a third aspect involves parties again, but this time summer rush parties at the homes of brothers around the state. The rush chairman notifies brothers in a particular locality about the rushees in that area. The brothers, be it one or five, plan a party at one of the brothers' homes and invite rushees from that city and other brothers and rushees from near by localities. An example of this type of rush function was the one held in Ft. Lauderdale last summer. The party was attended by about 25 brothers and rushees, with many of the guests coming from as far as Tampa. During the following two rushes, we pledged five men from that area of the state.

Of course, after a man is pledged, these points are not forgotten. They are ever present throughout the man's pledge period. A university policy is that a pledge maintain 12 hours with a 2.0 during his pledgeship; therefore, our pledges are constantly reminded to uphold their grades. We realize that a properly trained pledge builds a strong chapter and we feel our rush program is one of the keys to our continued success.

PLEDGE TRAINING PROGRAM

Definition and Objectives:

The pledge training program begins as soon as a rushee is pledged and continues until he is initiated into the brotherhood.

The goals of the pledge training program are:

- (a) To give the pledge knowledge of the ideas, goals, and traditions upon which Enotas Fraternity is based.
- (b) To instill in the pledge a desire for learning and academic achievement to his greatest potential.
- (c) To provide the pledge with an opportunity to develop leadership abilities through actual experience.
- (d) To acquaint the pledge with all facets of the University community, while stressing loyalty and service to the institution.
- (e) To provide an example of the democratic process in action thus instilling good citizenship and patriotism.
- (f) To develop the pledges personality, social conduct, and character.

Organization:

The responsibility for completion of the objectives outlined above, is assumed by the Pledgemaster. This individual is elected by the brotherhood and must have been an active brother of the fraternity for at least four semesters. The Pledgemaster directs the entire program with the help of the Assistant Pledgemaster.

One of the most important phases of the program is training the pledges for future leadership positions. This is accomplished by providing the pledge with an actual opportunity to lead. The pledge class elects its own officers who, after becoming familiar with the fraternity and the program, are given the additional responsibilities of planning, organizing and directing pledge class activities. Of course, the pledge class officers are continually advised and directed by the Pledgemaster. The officers of the pledge class are: President, Vice President, Secretary, Treasurer, and Historian.

In addition to the pledge class officers, three full time pledge committees handle pledge activities. The committees are: athletic, service projects, and fund raising.

Big Brother System:

Outstanding brothers are selected each semester to serve as advisors to the incoming pledges. These selections are made on the basis of academic standing, major field of study, time available, and degree of activity in the fraternity.

The Pledgemaster, in conjunction with the Pledge Advisory Board, appoints an outstanding brother to advise each pledge. This matching of pledge and brother is accomplished in light of the above criteria.

The functions of the big brother are:

- (a) To advise and assist the pledge in completing the requirements for initiation.
- (b) To meet with the pledge several times a week to keep him well informed of fraternity activities.
- (c) To represent the pledge before the High Court and the brotherhood.

Pledge Manual:

Each pledge is provided with, and is required to learn, the Enotas Pledge Manual.

The Pledge Manual is a twenty page booklet consisting of the following information:

- (a) A history of the Fraternity
- (b) A complete description of the chapter and pledge class organization and structure
- (c) All financial requirements
- (d) All obligations and requirements of the pledge class and the individual pledge
- (e) An outline of the Sturgis' Rules of Order
- (f) A statement of the rights of an Enotas pledge
- (g) A discussion on gentlemenly conduct
- (h) An explanation of the big brother system
- (i) Information pertaining to the origin and development of national fraternities
- (j) A complete schedule of University and Fraternity events
- (k) A complete roster of active brothers, graduates, and alumni, including information such as: addresses, major field of study, etc.
- (1) A graphic description of the role of the fraternity in the University community.

Program:

The pledge period is from fourteen to sixteen weeks in duration depending on rush and initiation dates. During this period the pledge must complete all requirements satisfactorily. If these requirements are not met, the pledge is repledged the following trimester. The following are the basic requirements of an Enotas pledge.

- (a) The pledge must complete 12 credit hours with a minimum GPR of 2.0 for the grading period during which he is pledged.
- (b) The pledge must thoroughly know all sections of the pledge manual. A pledge is required to demonstrate his knowledge of this manual by averaging at least 70% on the five periodic exams plus a minimum score of 75% on the final exam.
- (c) The pledge must meet all financial obligations. These are:

Pledge Dues	\$15.00

- (d) The pledge must participate in at least 60% of all social activities, 100% of all service projects, and 75% of all athletic events, unless such participation interfers with scholastic achievement.
- (e) The pledge must be present at all study halls if living on campus or within a radius of five miles of the university. If a pledge lives outside this radius, he must study a commensuate amount of time at his residence.
- (f) The pledge must demonstrate to the brotherhood:(1) That he conducts himself as a gentleman.
 - (2) That he is willing and eager to advance the interests of the university and the fraternity.
 - (3) That he practices emotional control, proper verbal behavior, and acceptable public appearance.
 - (4) That he actively participates in college and community activities.
 - (5) That he will perform cheerfully whatever tasks may be assigned to him for the good of the fraternity.
 - (6) That he accepts every member of Enotas without reservation or evasion.

SCHOLASTIC PROGRAMS

From the beginning, Enotas Fraternity realized that its success as a fraternity depended upon the academic success of both brothers and pledges. Consequently, scholarship has been a primary goal of the fraternity. To meet this objective, pledging is limited only to those men who have completed 12 hours with a 2.0 GPR. This in itself is certainly an incentive for men who are interested in affiliating with the fraternity. The university has established standards for national fraternities, one of which specifies that pledges must have 24 hours with a 2.0 GPR before initiation into brotherhood. In anticipation of this standard, our fraternity instituted this requirement during the fall of 1965, thus providing incentive for pledges to maintain their grades.

Another program initiated by Enotas to help pledges and brothers maintain their grades is the study hall system Study hall for pledges is under a system of supervision by designated brothers who are qualified to lend academic assistance. Study hall for brothers is under the honor system.

Still another method of providing incentive for scholarship is personal competition between the pledges. This competition comes in the form of two academic awards given to pledges at the end of the pledge period. These awards are presented to the pledge for the highest GPR and for the most improved GPR.

After initiation, equivalent levels of academic performance are demanded of the brothers. Any brother who is not in good standing with the university cannot be considered "active" in the fraternity, as stipulated by the fraternity by-laws. Brothers with below a 2.0 GPR are encouraged to avoid extra activities, such as a job, athletics, or committee work. This encouragement is, in most cases, sufficient to maintain a level of adequate performance required by the university and the fraternity.

The fraternity has a large test file at the disposal of the brothers. At this university, texts and tests are continually changing, so that old tests are used primarily to gain insight into material stressed, types of questions, etc.

In addition, the services of the more astute brothers are made available to members with scholastic difficulty for tutoring, advising, and counseling. The men with the higher grades assist others in planning a budget of study time, learning how to study appropriately, and how to present the proper image to professors.

The success of the above outlined program has been exemplified by the fraternity's continually increasing grade point average.

SERVICE ACTIVITIES AND PROJECTS

Enotas projects are designed to serve two purposes. The first and foremost goal deals with service projects. This category can be subdivided into service to the university and the community. The second purpose of these projects is to earn money for brotherhood activities. Within these two groups, it is necessary to subdivide the projects into brotherhood and pledge projects.

I. Brotherhood Projects:

An important community project which the brothers participated in was our care for an orphan. The orphan was a boy with whom the brothers frequently visited. We were making his life happier in supplying the basic necessities to one who was less fortunate. The boy was recently adopted which gave our brotherhood great satisfaction. Another community project is our Gasparilla Parade Coke Sale which is a joint service/finance project.

With regard to University service, we stress two projects. One of these is our annual campus clean up project. We named this Enotas "Help Keep USF Campus Green and Clean Week." On the way to classes or between classes, the brothers stop to pick up all litter thus helping to beautify our campus while encouraging other students to do the same. The other project of importance is our luggage moving program. For the full week prior to the first and last day of classes our brothers transport luggage for occupants of the three women's dormitories; Gamma, Delta, and Epsilon. This project saves the time and energy of many parents and new students, plus offering the student an opportunity to become acquainted with the fraternity. This is one of our best advertised and most entertaining projects. The fraternity also holds car washes and doughnut sales, with the proceeds going to the National Defense Education Assistance Scholarship Fund for the University of South Florida. For every dollar earned at these projects and contributed to the University, the government contributes ten dollars to the NDEA Fund. Thus, if the project makes twenty dollars the total amount deposited in the fund for scholarship use is two hundred and twenty dollars.

Most money making projects are held off campus in the surrounding community. Examples are the afore-mentioned Gasparilla Parade Coke Sale, as well as doughnut sales, and car washes.

11. Pledge Projects

The pledges of Enotas are always engaged in service to the university and the community. An example of these projects is the bi-weekly entertainment of underpriviledged children living in a nearby orphan's home. Our pledges take boys-age nine through thirteen-from the North Hillsborough County Orphanage to Lake Mineola. They arrive around ten o'clock and remain until around four o'clock. While at the lake, the pledges teach the boys how to swim, ski, play volleyball, football and other sports. After a fun filled time, the boys are treated to a hot dog and hamberger feast.

The pledges also participate in our Gasparilla Parade Coke Sale. They operate one stand while the brothers operate the other. The pledges, like the brothers, participate in doughnut sales and car washes to add to the university scholarship fund. They again help the brothers with our clean up campaign.

Pledges help the brothers with all money raising projects plus having a separate project. This is commonly called the pledge "Slave Sale." In this project each pledge agrees to work for a professor or staff member. The pledge works an eight hour day for the individual thus accomplishing the dual purpose of furthering the name of the fraternity and earning additional funds. For this work the pledge earns ten dollars which is deposited into the pledge treasury, a separate entity from the brother's account that is used for pledge activities.

An objective of all Enotas projects, whether they be service or money raising, is to unite brothers and pledges for common causesthe most important of which is service to community and university. When these men get together and work toward a common goal, a definite relationship emerges and brotherhood is obtained.

Another point is the high degree of participation. Enotas always have a large turnout for all projects. This is just one aspect of the fraternity of which Enotas is proud.

SPORTS PROGRAMS

The University of South Florida, as a young institution, has not ventured into major intercollegiate athletics as have most of the other, more well-established universities. Consequently, the University of South Florida has developed one of the strongest intramural programs in the nation. Intramurals have, in a sense, taken the place of major intercollegiate athletics. Considerable emphasis is placed on the intramural program by both the university and students. It is not uncommon to find 500 to 700 students attending an intramural football or basketball event.

From the infancy of this intramural program in 1960 emerged a team known as the Desert Rats. This team was a winning team because they had the desire to excel--and this desire to excel brought a closeness among them--this closeness was the beginning of ENOTAS Fraternity. From the very beginning, ENOTAS has long stood for supremacy in the area of intramurals on the South Florida campus. The desire to excel and the bond of brotherhood that developed on the playing field is still as strong in every brother as it was five years ago.

ENOTAS is now a member of the Fraternity League, the others being the Independent and Dormitory Leagues. The championship in each sport is determined by a play-off between the champions and runnersup in each league. We take pride in the fact that most of these play-offs, in every sport, will always have an ENOTAS team in it-and still greater pride in the fact that ENOTAS wins most of these play-offs.

We believe that the main reason for this constant excellence, as exhibited by our winning the I-M Championship three times and placing second the other two times, is the desire to participate that is exhibited not only by the players but also by the brothers on the sidelines. Any I-M game in which an ENOTAS team is fielded will find an actively enthusiastic group of brothers, pledges, and other independent supporters on the sidelines to cheer them on. This brotherhood has not only won the I-M Championship three times, but has won the Fraternity League Championship five consecutive times.

ENOTAS has not achieved this fine record at the expense of other more important areas such as academic achievement and leadership training activities. Rather, it is because the brothers of ENOTAS always take the court, field or diamond with the intention of winning. ENOTAS play to win--and most of the time they do.

SOCIAL ACTIVITIES

Enotas is proud of the training in social graces and etiquette available to its brothers and pledges. Our social events have this ideal as an underlying goal.

Rarely does a weekend pass without some type of social function for the brothers. If not a fraternity-sponsored party, one of the brothers will open the doors of his home for a Bar-B-Que, Luau, Bridge Party, or a Saturday-night Rush Party.
